## **EXPLANATION OF CHARGES**

Water Usage Charge

This charge is based upon your individual meter reading and pays the cost of treating the water and delivering it to your home or business.

**Water Base Charge** 

All customers pay a base charge based upon the size of their water meter. This charge pays for a portion of the water system's maintenance and service costs.

**Sewer Base Charge** 

All customers pay a base charge based upon the size of their water meter. This charge pays for a portion of the sewer system's

maintenance and service costs.

**Sewer Usage Charge** 

This charge is based upon the prior winter months average water usage. It pays the cost of conveying the waste water from your home

or business, treatment and eventual disposal.

**Storm Drain Charge** 

This charge pays for the operation and maintenance of the existing storm water system, plus creates a funding source to extend storm water facilities into neighborhoods currently without that service.

## Late Charges:

If payment is not received at City Hall by the 15th of the month, a late fee of \$15.00 will be assessed.

## **Reconnection Fee:**

If service is terminated for non-payment, all outstanding charges must be paid in full, plus a Reconnection fee of \$50.00. In addition, a deposit may be required.

## **Tamper Charge:**

A fee of \$150.00 will be charged for non-authorized use through our judicial system. Other penalties also may apply.
